## NAVSEA INSTRUCTION 5100.17

Subj: Occupational Safety and Health Control Manual (OSHCM)  
for Naval Shipyards

1. Purpose. To formally recognize the Occupational Safety and Health Control Manual (OSHCM) as a NAVSEA requirements document for the Naval Shipyards.

2. Background. The OSHCM was issued in reference (a). It serves as a primary source of requirements on shipyard OSH hazards that must be professionally controlled. The OSHCM augments Navy OSH policy in reference (b).

3. Policy. The OSHCM is a NAVSEA requirements document for the Naval Shipyards and shall be maintained consistent with higher authority OSH policy and standards in reference (b).

#### 4. Action

a. SEA 07C shall maintain the OSHCM and keep it consistent with reference (b) and other Navy OSH policy requirements. SEA 07C shall coordinate development with the Naval Shipyards.


b. The OSH Offices shall assist NAVSEA in the development and maintenance of the OSHCM. Mare Island Naval Shipyard shall provide OSHCM document integration, printing and distribution support to NAVSEA.

c. Code 106 shall be the local OSHCM interpretation authority.

d. Code 106 shall audit OSHCM implementation, identify deficiencies and track accomplishment of corrective actions.
