## **Noteworthy Accomplishments / Events:**

1963: Conducted experiments to determine carrier suitability of U2 aircraft.

1969: Awarded Presidential Unit Citation for action off Vietnam during the Tet Offensive.

1972: Racially motivated disturbances broke out on ship injuring between 47 – 60 men. The UPWARD (Understanding Personal Worth and Racial Dignity) Program established as a response.

1984: Ship collided with surfacing Soviet submarine in the Tsushima Strait. The submarine believed to be VICTOR I class K-314 damaged. A small piece of the submarine's propeller embedded in the CV-63 hull recovered and made into a souvenir. Now part of the Naval Historical Center collection.

1992: Supported Operation Restore Hope off Somalia

1998: Relived CV-62 as the forward deployed carrier in Yokosuka, Japan. With the decommissioning of the CV-62, she became the oldest active duty ship in the USN and assumed the honor of flying the First Navy Jack in lieu of the union jack.

2003: Participated in Operation Iraqi Freedom

2008: She is the last USN carrier with an oil fired steam plant. She is also the last USN carrier in service that was not built by Newport News Shipbuilding and Dry Dock Co.

#### **Conclusion:**

KITTY HAWK (CV-63) is eligible for listing in the National Register of Historic Places. She has an outstanding combat history and won the Presidential Unit Citation. Her construction marked to first refinement of the basic Forrestal design and resulted in a better laid out elevator placement leading to more efficient flight deck operation. These refinements were built into the follow-on carriers. On the social front, the racial disturbances in 1972 initiated reforms in the Navy culture.
