1. Purpose. To announce and document the mission, functions and tasks of the Naval Undersea Warfare Center Detachment, Concord, CA (NAVUNSEAWARCEN DET CONCORD CA) as required by reference (a).

2. Mission. Perform the In-Service Engineering Agent (ISEA) functions for the overall engineering, test, maintenance and logistics requirements incident to the AN/UYS-1 Advanced Signal Processor and the AN/UYS-2 Enhanced Modular Signal Processor. Perform the Computer Program Support Activity (CPSA) function for the AN/UYS-1. Also, perform such other functions and tasks as may be directed by higher authority.

3. Background. As a result of the Base Realignment and Closure (BRAC) 1993 process, Naval Aviation Depot, Alameda, CA was proposed for closure, necessitating realignment of the AN/UYS-1 and AN/UYS-2 ISEA and the AN/UYS-1 CPSA functions to another activity. In May 1994, the Navy Laboratory Commanders Coordinating Group (NLCCG) was tasked to review and determine the ultimate placement of this workload within the Warfare Center community. The NLCCG recommended transfer of these functions to the Naval Undersea Warfare Center and establishment of a detachment at WPNSTA CONCORD CA. Reference (b) directed Commander, Naval Undersea Warfare Center to initiate action to effect the transfer.

4. Status and Command Relationships. NAVUNSEAWARCEN NEWPORT DIVISION DET CONCORD CA is a category 2 detachment in an active, fully operational status under a civilian director. The detachment's chain of command and other organizational relationships are as follows:

Functions and Tasks of the
Naval Undersea Warfare Center Detachment, Concord, CA

1. For the AN/UYS-1 and AN/UYS-2, provide In-Service Engineering and Integrated Logistics Support (ILS) including design, safety, test support, technical documentation, specifications and standards, performance and maintenance data analysis, maintenance engineering, computer programs, installation, fleet engineering support, training and manning, data management, configuration management, test equipment, tools, jigs and fixtures, supply support and repair facilities.
2. For the AN/UYS-1, provide for the Life Cycle Support for the VAX Software Engineering Environment, the Program Generation and Development tools, the SPL/I Compiler and the CROS operating system and the ASP Executable Common Software. Provide configuration management, processing and implementation of software trouble reports and software change proposals, program library maintenance and preparation of software releases.
