## **Guidelines For Delivery/Ship Out Of Items Using Contracted Transportation**

The following is a guide to help execute a delivery or ship out of materials that will require the use of a contracted shipping company. This guide is designed to address precautions for personnel safety in regards to COVID-19, when a driver(s) have travelled outside of the local area. Use of this process will ensure there is no close contact with the driver and spread of COVID-19 is unlikely. Ensure all other safety precautions are taken as needed for the materials that you are having transported.

- 1. Preparations-
  - a. If at all possible, arrange for the shipping company/ driver to have current versions of the "CUSFF/NAVNORTH COVID-19 Screening Questionnaire" and "Norfolk Naval Shipyard Delivery Shipment/Receiving Entry Authorization Form" (if driver(s) has traveled domestically outside local travel radius).
  - b. Ensure the driver(s) has not traveled internationally in the last 14 days.
  - c. Ensure that required PPE/sanitization materials (e.g. face masks, hand sanitizer, washing station) are available as needed at delivery/ship out location for driver(s) and NNSY personnel.
- 2. Delivery/Ship Out
  - a. Ensure the driver has a readily available NNSY POC on day of delivery/ship out
  - b. Driver(s) will only exit the vehicle as absolutely necessary to load/unload equipment and material
  - c. If driver is required to leave the vehicle:
    - i. Driver(s) shall maintain a minimum of 6 feet distance between themselves and others (Social distancing)
    - ii. Driver(s) shall wear a mask at all times when outside truck (available at delivery /shipment site)
    - iii. Driver(s) shall wash hands or use hand sanitizer prior to or immediately after leaving the vehicle (available at delivery/shipment site)
    - iv. Driver(s) shall wash hands or use hand sanitizer prior to and after handling equipment, materials, or paperwork handled by others.
    - v. Other personnel supporting the delivery/shipment shall wear masks.
    - vi. Other personnel supporting the delivery/shipment shall wash hands or use hand sanitizer prior to and after handling equipment, materials, or paperwork handled by the driver(s).
- 3. Post Delivery/Ship Out
  - a. Driver(s) shall immediately depart installation after picking up/dropping off shipment
  - b. Sanitize any effected area as needed

  - Driver shall wear a mask at all times when outside truck (provided at delivery dock if necessary)
  - Driver shall wash hands or use hand sanitizer prior to or immediately after leaving the vehicle (provided at delivery dock if necessary)
  - Driver shall immediately depart installation after picking up/dropping off shipment
