



NAVSEA COVID-19 Screening Questionnaire



1.) Are you currently/have you experienced any of the following symptoms in the past 48 hours?

- fever (>100 °F) or chills
- muscle or body aches
- new loss of taste or smell
- cough
- fatigue
- headache
- sore throat
- diarrhea
- shortness of breath or difficulty breathing
- nausea or vomiting
- congestion or runny nose

If "YES", LEAVE/DO NOT ENTER the workplace. Military & Civilians immediately inform supervisor; CTR inform employer. Put a clean mask on when one is available and contact/report to your medical provider (call ahead to inform them of your pending arrival). Follow CDC Guidance.¹

2.) Are you traveling from a distance of greater >60 miles (outside of normal commuting distance)?

Fully Vaccinated Visitors:

If you're traveling to NUWC from within the United States (US) or from a location outside of the US, you do not need to ROM or get tested upon your arrival if you're fully vaccinated and remain symptom free.

People are considered fully vaccinated two or more weeks after they have received the second dose of a two-dose series or two or more weeks after they have received the single dose of the Johnson & Johnson (Janssen) vaccine.

Unvaccinated Visitors:

If you're traveling to NUWC Division Newport from a hot spot² within the US or from a country outside of the US, you must ROM for 10 days upon arrival or apply for a ROM waiver through your visit sponsor.

NUWCDIVNPT PERSONNEL RETURNING FROM TRAVEL MUST CONSULT THE COMMAND'S TRAVEL GUIDANCE³ PRIOR TO ACCESSING THE BASE.

3.) Within the past 14 days, have you been in close physical contact (6 feet or closer for at least 15 minutes) with a person who is known to have laboratory-confirmed COVID-19 or with anyone who has any symptoms consistent with COVID-19?

If "YES" and you are fully vaccinated, Military & Civilians immediately inform supervisor, CTR inform employer. You may enter the workplace provided you are not symptomatic.

If "YES" and you are unvaccinated, LEAVE/DO NOT ENTER the workplace, Military & Civilians immediately inform supervisor, CTR inform employer, put a clean mask on when one is available, and contact/report to your medical provider (call ahead to inform them of your pending arrival). Follow CDC Guidance. *Entry denied

4.) Are you isolating or quarantining because you may have been exposed to a person with COVID-19 or are worried that you may be sick with COVID-19?

If "YES", LEAVE/DO NOT ENTER the workplace. Military & Civilians immediately inform supervisor; CTR inform employer. Put a clean mask on when one is available and contact/report to your medical provider (call ahead to inform them of your pending arrival). Follow CDC Guidance.¹
