

## NAVSEA COVID-19 Screening Questionnaire



1.) Are you currently/have you experienced any of the following symptoms in the past 48 hours?

- fever (>100 °F) or chills
- cough
- muscle or body aches
- fatigue
- sore throat
- diarrhea
- nausea or vomiting
- congestion or runny nose
- new loss of taste or smell

   shortness of breath or difficulty breathing

If "YES", LEAVE/DO NOT ENTER the workplace. Military & Civilians immediately inform supervisor; CTR inform employer. Put a clean mask on when one is available and contact/report to your medical provider (call ahead to inform them of your pending arrival). Follow CDC Guidance.<sup>1</sup> \*Entry denied

- 2.) NUWCDIVNPT visitors, are you traveling from a distance of greater > 60 miles (outside of normal commuting distance) to get here, or have you traveled internationally in the past 14 days? YES NO

If "YES", LEAVE/DO NOT ENTER the workplace unless you:

- (1) have a 14-day ROM waiver approved by the Commanding Officer of NUWC, which you must present to Security
- (2) are on TDY and have followed the Command's travel guidance<sup>2</sup>
- (3) have completed a 14-day ROM with a bubble-to-bubble transfer.

Military Personnel: Complete 14 days of ROM. Civilian Personnel/CTR: Base Entry denied for 14 days. Follow CDC Guidance.<sup>3</sup> \*Entry denied

NUWCDIVNPT PERSONNEL RETURNING FROM TRAVEL MUST CONSULT THE COMMAND'S TRAVEL GUIDANCE<sup>2</sup> PRIOR TO ACCESSING THE BASE.

3.) Within the past 14 days, have you been in close physical contact (6 feet or closer for at least 15 minutes) with a person who is known to have laboratory-confirmed COVID-19 or with anyone who has any symptoms consistent with COVID-19?

4.) Are you isolating or quarantining because you may have been exposed to a person with COVID-19 or are worried that you may be sick with COVID-19?
