- c. 31 MAY 2024: SSRAC Coordinator to provide serialized copy of Change Proposals to each subcommittee
- d. 08 JULY 2024: Convene SSRAC meeting. All VASCIC rooms available for Subcommittee work.
- e. 09 JULY 2024: Convene SSRAC meeting. (General Assembly) This is the first full day for all attendees (In brief is scheduled for 0800).

- b. Please be sure to indicate whether the proposal is "Administrative" or "Technical" in nature, and whether or not there is a cost or schedule impact. Incomplete forms will be returned.
