1. This letter identifies activities authorized to certify Level I material per the requirements of references (a) and (b). Enclosure (1) provides the Certifying Activity Designators (CAD) assigned to activities currently authorized by Naval Sea Systems Command (NAVSEA) to certify Level I material. Enclosure (2) is a list of activities and their corresponding inactive Level I CADs. Inactive CADs represent activities that are either no longer in operation or have not performed sufficient Level I material certifications within the past 24 months. References (c) and (d) provide amplifying guidance.

2. This letter cancels NAVSEA ltr 4855 Ser 06/028 of 14 Apr 25.

3. Authorization for an activity to certify Level I material is provided by the NAVSEA Materiel Readiness Department (SEA 06M) to activities that have acceptable quality and material control procedures, facilities, trained personnel and demonstrated ability to comply with reference (a) requirements. All activities authorized to certify Level I material will be subject to periodic compliance audits by SEA 06M and, where applicable, the cognizant Navy oversight activity. Activities that are classified as inactive or that have been disqualified are subject to a re-qualification audit by SEA 06M prior to reinstating their CAD.

4. When problems are detected with a Level I certifying activity's ability to certify and control Level I material, the cognizant Navy oversight activity or responsible activity commander must notify SEA 06M of any problems found and take corrective and preventive measures to eliminate underlying root causes. If timely corrective and preventive actions are not taken and problems persist, the responsible Navy oversight activity or responsible activity commander must suspend the contractor's Level I Material Program and notify SEA 06M immediately to determine further action required, up to and including CAD revocation.
