Noteworthy Events	USNS PFC Eugene A. Obregon was delivered as the SS Thomas Heyward in 1983 to the U.S. Maritime Administration. The U.S. Navy acquired the Thomas Heyward under a long term charter in 1985 and she was converted to a roll on - roll off container ship at National Steel and Shipbuilding in 1985. Renamed and placed into service that same year, the SS. PFC Eugene A. Obregon was assigned to the Military Sealift Command European Area as a chartered, contractor operated maritime preposition ship. The vessel was acquired by Military Sealift Command and placed into service as the USNS PFC Eugene A. Obregon. The Eugene A. Obregon was assigned to the Atlantic Fleet. The vessels namesake Is USMC Medal of Honor recipient Pfc Eugene A. Obregon.
