Vessel History

<p>Deployment Summary</p>	<p>1 November 1996, The U.S. Navy's Coastal Patrol Boat USS Chinook returns to her home at Little Creek Amphibious Base, Norfolk, VA, with two rigid hull power boats carrying members of the SEAL teams, returning from a Mediterranean deployment. This deployment marked the second Mediterranean cruise for the Navy's new class of coastal patrol ships.</p> <p>From November 2001 on, the Cyclone - class ships were temporarily operated under US Coast Guard control for homeland defense.</p> <p>18 January 2003, Deployed from Naval Amphibious Base Little Creek, VA. in support of operation Enduring Freedom. For Operations Enduring Freedom and Iraqi Freedom, the Chinook was deployed to the Persian Gulf for 18 months from 2003 to 2004. During the deployment, Chinook's crew was swapped out every 6 months. Such a "crew swap" initiative increases the Navy's forward presence by providing an extra 90 days of on-station time per vessel.</p> <p>21 March 2003, At sea in support of Operation Iraqi Freedom.</p> <p>4 October 2008, Persian Gulf, USS Chinook conducted maritime security operations in the Persian Gulf near the Iraqi Khawr Al Amaya oil terminal (KAAOT). USS Chinook was part of Combined Task Force (CTF) 158, which is specifically responsible for ensuring the security of Iraq's KAAOT and Al Basra oil terminals in support of U.N. Security Council Resolution 1790. CTF-158 operates jointly with Iraqi Navy sailors and marines, trained by members of the Navy Transition Team based in nearby Umm Qasr.</p> <p>25 March 2009, Umm Qasr, Iraq, USS Chinook, departed Umm Qasr, Iraq, after completing the first overnight port visit to Iraq by a U.S. Navy ship. While in port USS Chinook took on fuel and other supplies and crewmembers participated in friendship-building activities with several senior Iraqi officers. A port visit by the U.S. Coast Guard Cutter Aquidneck (WPB 1309) to Umm Qasr on Dec. 15, 2008 was the last visit by a U.S. ship to the Iraqi port.</p> <p>17 November 2015, Arabian Gulf, USS Chinook, was attached to Commander, Task Force 55 (CTF 55), transiting through the Arabian Gulf</p>

	<p>to participate in Warfighter Training 2015. Warfighter Training is a CTF 55-led joint service, integrated training event with U.S. naval and Coast Guard surface and air forces in the Arabian Gulf to support refinement of tactics and procedures.</p> <p>18 July 2017, Arabian Gulf, A griffin missile is launched from the coastal patrol ship USS Chinook during a test and proficiency fire. USS Chinook was one of 10 coastal patrol ships assigned to Coastal Patrol Squadron 1, which was forward deployed in Manama, Bahrain, in support of maritime security operations and theater security cooperation efforts in the U.S. 5th Fleet area of operations.</p>

Noteworthy Events	<p>On 10 January 2023, Chinook, along with sister patrol ship USS Monsoon (PC-4) and guided-missile destroyer USS The Sullivans (DDG-68), stopped and boarded a fishing vessel in the Gulf of Oman that was smuggling over 2000 AK-47 assault rifles.</p> <p>On 28 March 2023, ex-Chinook (PC 9) was transferred to the Philippines Naval Forces as the BRP LADISLAO DIAZ (PS-178).</p>
