Deployment Summary	On 1 November 1996, Firebolt returned from a Mediterranean deployment. This deployment marked the second Mediterranean cruise.
	On 10 March 2003, Firebolt forward deployed to Kuwait and conducted missions in support of Operation Enduring Freedom.
	16 February 2004, Firebolt suffered a 3- to 4-inch gash in her hull and experienced minor flooding, after the ship collided with a buoy off the Iraqi coast. Nobody was injured in the accident.
	On 24 April 2004, two Firebolt Sailors and a Coast Guardsman were killed as Firebolt provided security for the Khawr Al Amaya Oil Terminal in the Northern Arabian Gulf. After spotting a suspicious vessel, Firebolt deployed a rigid-hull inflatable boat and the suspicious vessel exploded in an apparent suicide attack.
	"We thank the hundreds who served on this great ship and honor the brave Sailors and Coast Guardsman killed in the 2004 terrorist attack at sea. Their sacrifice will never be forgotten," said Vice Adm. Brad Cooper, commander of U.S. Naval Forces Central Command, U.S. 5th Fleet and Combined Maritime Forces.
	In April 2005, Firebolt rescued survivors from the Gulf of Aden after their small craft capsized off the coast of Somalia.
	On 29 April 2005, Firebolt tended to some of the 89 survivors rescued from the Gulf of Aden after the small vessel they were traveling in capsized 25 miles off the coast of Somalia. The guided missile cruiser USS Normandy (CG-60), coastal patrol ship USS Typhoon (PC-5), and German frigate FGS KARLSRUHE (F 212) assisted in the rescue effort.
	On 20 October 2005, Firebolt deployed in the Persian Gulf conducting scheduled Maritime Security Operations (MSO) setting the conditions for security and stability in the maritime environment.
	On 7 March 2007, Firebolt was underway with Combined Task Group 158.1 performing Maritime Security Operations (MSO) in the North Arabian Gulf (NAG). MSO helped set conditions for security and stability in the NAG and protected Iraq's sea-based infrastructure, which provided the Iraqi people the opportunity for self-determination.
	On 13 August 2008, Firebolt arrived at the port of Umm Qasr making the port visit as part of Iraq Navy Day celebrations, marking the first visit by a U.S. ship to Iraq in more than 15 months.

	On 1 October 2011, Firebolt performed an exercise in the Arabian Gulf. On 21 May 2013, Firebolt and the Royal Navy destroyer HMS DRAGON (D 35) were underway during International Mine Countermeasures Exercise (IMCMEX) 2013. IMCMEX 13 included navies from more than 40 countries whose focus was to promote regional security through mine countermeasure operations in the U.S. 5th Fleet area of responsibility. On 28 April 2021, Firebolt fired warning shots when vessels of Iran's paramilitary Revolutionary Guard came too close to a patrol in the Persian Gulf.

Noteworthy EventsPrior to operating from Bahrain, the ship helped secure New York C harbor immediately following the terrorist attacks in the United State 11 September 2001. Months later Firebolt conducted coastal patrols Arabian Gulf during Operation Iraqi Freedom.	
	Firebolt conducted several major rescue operations during its storied service. In 2005, the ship's crew rescued 89 people off the coast of Somalia after their boat sank. Additionally, Firebolt rescued an Iranian mariner from a capsized fishing vessel in 2012.
	On 30 March 2022, Firebolt was transferred to the Royal Bahrain Naval forces as the RBNS Jenan (PC-73).
