Benavidez participated in Defender-Europe 2020 exercise as the largest deployment of US-based forces to Europe in 25 years, with some 20,000 soldiers deploying from the US to join another 17,000 troops from 17 other countries.</p> <p>The Defender-Europe 2020 exercise took place in April and May 2020, set up to get some of those soldiers and their gear to Europe, the US Military Sealift Command cargo ship Roy P. Benavidez and US-flagged merchant vehicle carriers MV Resolve and MV Patriot are already sailing across the Atlantic, escorted by guided-missile cruiser USS Vella Gulf.</p>
