6.職務内容 Duties

We are seeking a versatile Program Analyst to join our agile analytical team. In this dynamic role, you will provide critical, cross-functional support across our branch's three core pillars: Strategic Analysis, Performance Analysis, and Data Systems having the unique opportunity to build broad analytical expertise, rotating through diverse projects as operational needs dictate. The analyst collaborates with counterparts at the Yokosuka departments and the Sasebo and Singapore detachments to ensure command-wide alignment.

1. Supporting Strategic Analysis and the Planning, Programming, Budgeting, and Execution (PPBE) Process
 - Assists in the development of the Program Objective Memorandum (POM) by gathering, compiling, validating, and analyzing data on future year resource requirements.
 - Supports the development of the command's annual Execution Year Guidance (EYG) proposal by making data calls and compiling information.
 - Leads well-defined, moderately complex organizational studies focusing on future design and capability gaps.
 - Develops and adapts existing analytical models (e.g., workforce planning, cost analysis) to support strategic "what-if" scenarios.
2. Executing and Managing Performance Analysis
 - Independently manages the full monthly production cycle for the command's key recurring performance reports (e.g., BisFin, MBM, MER).
 - Performs initial analysis to identify significant deviations from the annual plan within the BisFin/MBM/MER.
 - Conducts in-depth analysis of performance metrics to identify trends and root causes.
 - Prepares and presents comprehensive reports and briefs on a wide range of analytical topics to mid-level management.
3. Applying Data Systems Analysis Techniques
 - Develops, maintains, and optimizes end-to-end data solutions, from back-end data extraction from enterprise systems and Extract, Transform, Load (ETL) processes to front-end Business Intelligence (BI) dashboards and visualizations.
 - Serves as a power user of BI tools, developing and maintaining specific dashboards and reports that visualize command data.
 - Implements data quality checks and performs root-cause analysis on data discrepancies.
 - Contributes to the documentation of data dictionaries and analytical models.
