- Reviews and prioritizes work requests, allocating resources based on mission urgency, complexity, and workforce capability.
- Provides technical oversight and guidance on complex engineering problems involving ship structures, propulsion systems, utilities, and lifting equipment.
- Develops, reviews, and approves technical work documents (TWD), specifications, cost estimates, and engineering standards.
- Coordinates with U. S. Navy, Army, and Coast Guard stakeholders and higher headquarters to resolve critical engineering and operational issues.
- Establishes and implements local engineering standards, policies, and procedures in alignment with NVSEA and applicable regulations.
- Leads workforce development, including training plans, performance evaluation, and recommendations for hiring, promotion, and reassignment.
- Participates in executive-level planning and decision-making as a member of the Executive Steering Committee (ESC), contributing to strategic goals and command policies.
- Represents the command in high-level meetings, negotiations, and technical discussions related to engineering operations.
- Participates in Department Leadership activities as Planning Division Representative.
